If your application is dependent on receiving a scholarship, please indicate on the nomination form.

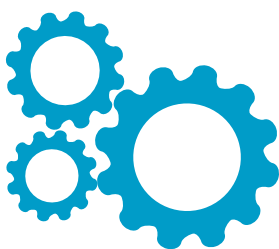

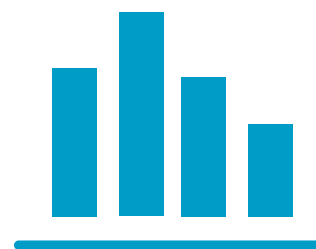
