

WHAT IS LGPRO?

LGPro is the peak body for Local Government professionals in Victoria. LGPro develops and delivers high quality professional development activities and services, facilitates positive communication between the sector and State and Federal Governments, and represents the views of officers where expert advice is required about legislation and policy and program development. LGPro's members across the state represent the professionals of Victoria's 79 Councils.

Amongst other things, LGPro's role is to:

- Represent local government professionals in Victoria advocating on behalf of members and the sector on all professional matters, and provide a unified collective voice in influencing local government policy direction
- Advance fellowship and communication amongst local government professionals and strengthen members' professional status and integrity
- Recognise excellence amongst those who have made a significant contribution to local government

WHAT IS THE CORPORATE PLANNERS NETWORK?

The Corporate Planners Network is a special interest group of LGPro, and membership is open to any Victorian local government employee who has an interest in any aspect of local government planning. This includes disciplines such as corporate planning, community planning, strategic land use planning, social planning or health planning.
