

LGPro Council Subscription Terms and Conditions

Congratulations on your Council's subscription to LGPro which gives your council access to leadership training and other professional development courses, professional networking, and engagement opportunities.

Your subscription is subject to the following Terms and Conditions.

Terms and Conditions

LGPro Council Subscriptions are valid for a minimum of 12 months, paid in advance. Your subscription will be validated two days after your initial payment has been received.

As an LGPro subscriber, your council is required to:

- comply with LGPro's:
 - * Rules of Association
 - * Privacy Policy
 - * Special Interest Group Code of Conduct
- not transfer your LGPro Council Subscription and associated benefits to any other council or any other organisation.
- not use LGPro's logo or trademark without prior written permission from LGPro

Subscription Renewal

- Unless cancelled, your subscription will automatically renew on 1 July every year. You will be sent a renewal invoice by 1 May of each year.
- Any increase in subscription fees will be advised in the renewal notice.

Subscription Cancellation

- You can cancel your Council Subscription by providing 30-days written notice and paying any outstanding invoices. Your subscription will be cancelled at the end of the 30 days.
- Subscription fees may be refunded on a pro-rata basis if you cancel before renewal is due.
- Subscription cancellation will end your council's participation in subscription-only training and professional development programs. Specifically:

Leadership Courses: If a council cancels its Subscription while its staff are participating in a leadership course which is only available to subscribers, staff will be able to complete their course without disruption. If staff have not yet commenced their training, their enrolment will be cancelled with the Subscription.

Awards: If a council resigns from its Subscription while staff are in the process of submitting award nominations, a non-Council Subscription award nomination fee will be charged.

Australasian Management Challenge: In the event a council resigns from their Council Subscription when staff are in the process of submitting a team nomination to participate in the Australasia Management Challenge, the team nomination will be cancelled.

Special Interest Group Network: If a council resigns from their Council Subscription when staff are accessing the LGPro Special Interest Group Network, staff will be notified and given a grace period of 30 days to become either Fellow, Professional, or Young Professional members to continue accessing the Special Interest Group Network. If this option is not taken, affected staff will be unsubscribed from the Network.

Free memberships linked to Council Subscription: In the event a council resigns from their Council Subscription when staff are using the free memberships linked to the subscription,

staff will be notified and given a grace period of 30 days to become either Fellow, Professional, Young Professional, or WebinarHQ members in order to continue accessing member benefits. If this option is not taken, free memberships and retrospective benefits will be cancelled.

Advocacy and Representation: LGPro represents the views of the Local Government sector and its professionals in the form of official submissions to research projects, reform proposals, and broader consultation. In the event a council resigns from their Council Subscription, the council will not be involved in the LGPro consultation process.

Subscription Cancellation

- LGPro reserves the right to suspend or cancel your subscription if:
 - * your Council Subscription annual fees are more than three months in arrears.
